



Success Criteria	Measures	Performance <ul style="list-style-type: none"> At least 75% of students participating in the pilot program will demonstrate measurable reading growth by progressing a minimum of one cluster within the agreed scope and sequence, relative to their identified baseline. At least 75% of students participating in the pilot program will demonstrate improved engagement in reading instruction, evidenced by an increase of one level on the engagement scale or the sustained maintenance of Level 5 (high engagement) where this is the student's baseline.
		Behaviour Students will: Participate in explicit, structured and differentiated reading experiences differentiated to their needs, demonstrating their learning through varied evidence and showing improved reading and engagement outcomes across the school. Teachers will: Collaboratively plan and implement reading instruction using agreed school processes, applying high-impact practices, and differentiated content, tasks and supports. They collect and map evidence of reading development to curriculum and individual learning goals. Teacher aides will: Implement targeted reading supports under teacher direction, reinforce key skills through structured practice, and assist students to engage with differentiated tasks. Leadership team will: Lead the rollout of reading through Australian Curriculum V9 and manage the selection and implementation of evidence-based pedagogies and programs informed by school and cohort reading data. Engage in walks throughs, observation and feedback sessions with pilot class teachers and build their own capability in reading.
